#### TBWA STALLION TENDER SCHEME Terms and Conditions of Tenders

1. Tenders will close on the **1st August 2018** at 5pm or until tendered and shall be submitted on the official Tender Form to; **TBWA, PO Box 178, Belmont WA 6984** or **info@tbwa.net.au**
2. Tenders will be accepted from Members and Non-Members.
3. **No tender below 50% of the published service fee will be accepted** and it is expected that most successful tenders will be in excess of this figure.
4. Successful tenders on the first round shall be notified as soon as possible and within seven days.
5. A non refundable deposit amounting to 10% of the tendered service fee shall be payable to the TBWA Stallion Tender Scheme within seven days of notification of the mare owner being the successful tenderer and before the mare goes to stud.
6. The tenderer understands that he/she may forfeit the service right to the stallion on failure to pay the deposit within the specified period required under clause 5 and that it may be offered to another tenderer.

7. The successful tenderer agrees to pay the balance of the tendered service fee to the TBWA Stallion Tender Scheme within thirty (30) days of being advised of a 45 day positive pregnancy test on his/her mare or within 30 days of the mare leaving the stud whichever occurs first.
8. Free returns apply on all stallions nominated for the TBWA Stallion Tender Scheme.
9. The tenderer agrees that the tendered service fee is confidential and undertakes not to discuss or disclose any successful tendered service fee with any other person.
10. The mare's name, age, pregnancy status (in foal/empty) and breeding record (including date of last service) must be supplied with the tender application.
11. The tenderer agrees to pay all agistment fees, transport, veterinary and other costs incurred in respect of the subject mare whilst at stud under the TBWA Stallion Tender Scheme. The rate applicable may be obtained directly from the stud or other provider and fees will be charged and paid directly between the broodmare owner and the stud or other provider.

12. The tenderer acknowledges that if the mare is presented to the stud on a "walk in" basis the stud may charge an additional fee for such service. If a mare owner is contemplating such an approach, this should be noted on the Tender Application.
13. The tenderer agrees that in the interests of the stallion, stud hygiene, and other mares, the stud reserves the right to withhold service from any mare which is infected, diseased or intractable.
14. The tenderer and the stud accept that the condition of the mare whilst at stud are outside the control and responsibility of the organisers of the TBWA Stallion Tender Scheme.
15. The tenderer understands that the highest tender will not necessarily be accepted.
